Elderday is Moving to A Brand New Facility



Elderday is moving to Watsonville! This fall The Central California Alliance for Health awarded Elderday a \$2.5 million grant that will allow the Adult Day Health Care provider to move from its current location in Santa Cruz to a more modern, spacious facility in Watsonville. Along with Community Bridges Board of Directors which has authorized a significant portion of the programs reserves to invest in the future needs of our aging population.

The new location will allow Elderday to better serve the growing Santa Cruz County senior population in a strategic location that will allow us to serve the fastest growing segment of our community while offering a diverse array of therapeutic services, assessments and onsite social activity programming.

Elderday plans to move to its current location in late 2022 – with the growing demand and the need for increased services and the need to fix our occupancy costs we needed to relocate. The new facility offers an additional 3,600 square feet of space for activities and care.

A huge thank you to the Alliance for making this vision a possibility with their support for Elderday's long term vision for Santa Cruz County seniors!

Families with Kids Under 18 – Apply for the Child Tax Credit Today

Families with children under 18 years old, who were born in the United States, are eligible to receive the California Earned Income Child Tax Credit (CEICTC) passed by Congress earlier this year regardless of their parents' immigration status.

The credit provides income for all families with children under 18 but parents who did not file a 2020 income tax statement may need to apply in order to receive their child's benefit.

Receiving the tax credit on behalf of your eligible children, will not affect the parent's immigration status or ability to apply for a green card.

For assistance with the application process, Santa Cruz County residents may contact Community Bridges' EICTC/ITIN helpline (831) 316-3332. Our Family Resource Centers can help direct callers but they cannot provide tax advice.
