Who: The free event is open to all attendees. 3rd District Candidates Justin Cummings and Ami Chen-Mills are confirmed and 4th District Candidates Jimmy Dutra and Felipe Hernandez are also confirmed. The event is open to all officially filed and declared candidates appearing on the June 7 ballot.

Format: Candidates will open the forum by giving brief opening statements about their candidacy. They will each be asked to respond to several previously developed questions before opening the floor to attendees to engage with the candidates directly.

Spanish translation assistance will be available to attendees.
