Elderday opens, Lift Line expands, and hunger increases



Elderday's Grand Opening Marks Significant Expansion of Local Older Adult Services

On October 12, we marked a momentous occasion with the grand opening of Elderday Adult Day Health Care's new state-of-the-art headquarters at 501 Main Street, Watsonville. This remarkable event signifies an expansion in response to the growing need for older adult services in Santa Cruz County and the Central Coast.

Since its establishment in 1981, Elderday has been a lifeline for countless older adults, offering essential services such as nursing care, therapies, mental health resources, activities, nutritious meals, and social interaction to prevent early institutionalization. Elderday's mission revolves around improving the well-being of vulnerable older adults, helping them live fulfilling lives at home.

In 2021, Community Bridges secured a substantial \$2.5 million capital grant from the Central California Alliance for Health to acquire the impressive 12,591-square-foot property in downtown Watsonville. Construction began in April 2022, and as of September 2023, the facility stands as a testament to Elderday's and the Alliance for Health's commitment to the older adult community.

The new location offers 3,600 additional square feet, allowing for a 30% increase in capacity fostering transformative intergenerational activities with other Community Bridges programs. The proximity to Community Bridges headquarters at 519 Main Street enables collaboration with programs like La Manzana Community Resources, WIC, and the Child and Adult Care Food Program.

Key speakers at the event emphasized the increasing need for programs like Elderday. The number of older adults in California is rising, making such services essential. Santa Cruz County has seen an 80.9% growth in the 65-84 age group since 2010. Studies reveal that 1 in 5 older adults in Santa Cruz County live in isolation, posing added risks to their health and well-being.

Elderday is a vital Community-Based Adult Services (CBAS) program and the only program of its kind combating senior isolation in Santa Cruz County and the Central Coast. Their compassionate programs provide companionship, enrichment, and nourishment, allowing older adults to continue living at home within their families and communities.

As the need for these services continues to grow, Elderday's expansion will extend its reach to San Benito and Monterey Counties, ensuring more older adults can access care and companionship that would otherwise be out of reach. Elderday services are provided for just a fraction of the cost of assisted living (42%) and nursing home care (24%) and are covered by Medi-Cal and Veterans Administration.

As we celebrate the remarkable journey that has led us to the grand opening of Elderday's new state-of-theart headquarters, we are reminded of the critical importance of the services we provide to older adults in Santa Cruz County and the Central Coast. The development of this project was 100% self-financed by Community Bridges, without a large capital campaign or community fundraising drive.

Breaking Barriers: Lift Line Access for All Program Expands Inclusive Transportation in Santa Cruz County

Community Bridges is thrilled to announce the expansion of its Lift Line transportation program to better serve all Santa Cruz County residents with disabilities. Thanks to the generosity of a state grant from the California Public Utilities Commission (CPUC) Transportation Network Company's (TNC) Access for All program through our local Regional Transporation Commission (RTC), we're launching a groundbreaking initiative to further make transportation accessible for everyone, regardless of income.

The Lift Line Access for All Program Features:

- Unique Door-to-door transportation for all county residents with disabilities.
- An affordable flat fee of just \$5 per ride (income-eligible older adults and individuals with disabilities ride for free).
- Extensive countywide coverage, ensuring everyone has access to ADA-accessible transportation.

Why It Matters:

A typical 18-mile taxi ride from Watsonville to Santa Cruz can cost nearly \$100, making it unaffordable for many residents who require wheelchair-accessible vehicles. Additional low-cost and barrier options, such as ParaCruz, may cost up to \$14 per ride and have limited pickups due to reduced coverage area, leaving rural low-income participants without other options. Our \$5 fee is one of the lowest rates in the county for countywide trips, ensuring affordability and accessibility.

Convenient Scheduling:

We're introducing a self-service mobile app similar to popular ridesharing services like Uber and Lyft. This app allows you to schedule rides up to seven days in advance, with same-day pickups based on availability. To schedule your rides, simply call 831-688-9663 to register for the program and receive a log-in for our app. Then, you can choose to schedule your rides through the app or over the phone.



Combating Hunger, Building Hope: A Year-End Reflection and Call to Action

It's hard to believe that the end of 2023 is quickly approaching. We find ourselves in a pivotal moment for our community and our nation. The challenges brought by the past 12 months have been immense, and one of the most pressing issues we face is the alarming increase in hunger and food insecurity. We must reflect on this crisis and take bold action to address it.

In 2021, thanks to pandemic relief efforts, we saw a brief improvement in hunger and food insecurity for our community, however, the latest findings from the U.S. Department of Agriculture's Economic Research Service (ERS) report have brought to light a concerning trend for 2022. Here are some key takeaways from the report:

- 1. The number of people living in households struggling with hunger in 2022 increased by 10.3 million compared to the previous year.
- 2. Shockingly, one in 8 households in the United States now face food insecurity.
- 3. The number of children living in households experiencing food insecurity rose significantly, affecting 13.4 million children a 44.6% increase from the previous year.
- 4. Single-parent households headed by women experienced a particularly high level of food insecurity, with a rate of 33.1%.
- 5. The report highlights the disproportionate impact of food insecurity on Black and Latine households, with both groups experiencing double the rate of White non-Latine households.
- 6. Rural areas faced a higher prevalence of food insecurity (14.7%) compared to urban areas (12.5%).
- 7. Even households with incomes below 185% of the poverty threshold experienced a significant level of food insecurity, with a rate of 32%.

To address this growing crisis, the ERS report suggests several policy measures, including additional funding for programs like the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC), expanding the Supplemental Nutrition Assistance Program (SNAP), reinstating the Expanded Child Tax Credit (CTC), and making free healthy school meals available to all children nationwide.

The report serves as a stark reminder of the urgent need for Congress to make substantial investments in anti-hunger and anti-poverty programs and that local governments must take a proactive role in helping address these community issues. It shouldn't be controversial for us to state that no one in our country should go hungry, especially when viable solutions exist. It's a pressing issue that demands attention and action to ensure the well-being of all community members.

In these challenging times, the support and advocacy of our community are more important than ever to ensure that addressing the most basic need of hunger is prioritized and addressed. Community Bridges has been at the forefront of delivering essential services and critical resources. We have responded swiftly during

times of crisis, thanks to the generosity and support of individuals like you.

Over the past year, our community has faced natural disasters, including storms that led to flooding and displacement. In response, Community Bridges provided over \$1.7 million in direct assistance to those affected, and we continue to support families in their rebuilding efforts. Most government aid has ended, leaving many facing loss of expanded services, escalating inflation, increased housing costs, and the threat of falling into poverty.
