



# Community Bridges Counseling Program: Bridging Gaps, Transforming Lives

The Community Bridges Family Resource Collective (FRC) stands as a source of hope and assistance for more than 10,000 individuals each year in Santa Cruz County and North Monterey County. Among its many vital programs, the Counseling Program, led by Clinical Supervisor Bryan Giese-Gardner, plays a pivotal role in providing mental health services to children, parents, and families who often find themselves unable to access or afford professional assistance.

The counseling program extends its compassionate arms across the FRC's four locations in Watsonville, Santa Cruz, Live Oak, and Felton. The program started in 2018, following a client survey in which community members indicated both the availability of clinicians and having services in their language, as well as with a clinician that understands their culture, were important assets to the community. The counseling program's mission is clear: to ensure that the ability to pay should never be a barrier to receiving the care needed to improve one's quality of life with a clinician who can relate to one's experiences.

"Our mission is to make sure that people have access, who typically wouldn't have access, and that the ability to pay or not is not a determining factor of someone receiving the kind of care that they would need in order to improve their quality of life," says Bryan.

**A Growing Need** 

As the COVID-19 Pandemic continues to cast its long shadow, the need for mental health services has surged. The overflow of clients in traditional mental health services has left many, particularly children and adults, without the support they require.

"The need for mental health services has been increasing and the acuity with which people come in is higher than it's been," Bryan says. "A lot of traditional programs that are far more intense and high frequency services have been inundated with people who have lots and lots of issues."

The counseling program not only offers individual child, teen, adult, and family counseling for general mental health issues but also serves as a crucial link for those facing more acute needs. Bryan acknowledges the challenging reality of delays and disruptions in accessing mental health care, but he emphasizes the program's commitment to decreasing lag time and increasing access for people, even if they cannot provide immediate counseling services.

#### **A Communal Space**

In a community space like Community Bridges' FRC sites, the counseling program serves as a connector, a place where individuals who live in some of the Central Coast's most overlooked communities can voice their struggles and be guided to the right resources.

"The FRC serves as one of the ultimate connectors in different pockets of the community... that ability to feel like you can come in and say, 'I'm not really sure what I want, I'm not really sure. But here's what I can share about what's happening for me,' and people can point you in a good direction that isn't a dead end."

The impact of the program is not just measured in the number of clients served but in the stories of transformation that unfold within its walls. While Bryan cannot disclose specific cases, he highlights the profound change that often begins with someone simply feeling heard and validated.

"Simply by someone listening and validating that they have gone through difficulty and that they have been hurt or wounded and have some pain and suffering, gives them strength and gives them the feeling like they have choices, they have options," he shares.

#### **Families First**

Beyond individual impact, the program plays a crucial role in supporting families dealing with school difficulties and developmental issues. Bryan stresses the importance of affirming differences and helping parents advocate for their children in a system that often fails to listen to the needs of the most vulnerable.

"Being able to meet families, affirm someone's differences, and not see them through this lens where they're coming up short, where they're falling behind, is a really important aspect of us taking care of populations that don't have a lot of power socially."

#### **Building Blocks**

As the demand for mental health services continues to rise, the Community Bridges Counseling Program is at the forefront of bridging the gaps in access and care. However, it cannot achieve its mission without the support of the community.

### Over \$81K Raised to Support Evicted Pajaro Farmworker Families

We are thrilled to share the incredible news of our community's compassion and generosity! Thanks to your unwavering support, we have successfully raised over \$81,000 to assist more than two dozen farmworker families in Pajaro who were facing imminent eviction during the holiday season.

A special note of gratitude goes to the Community Foundation for Monterey County and the United Way of Santa Cruz County, who demonstrated remarkable leadership by contributing grants of \$50,000 and \$10,000, respectively, to our fundraising campaign. Their commitment to our community has been instrumental in making a significant impact.

With the combined power of these grants and the support of over 130 individual donors, ranging from \$5 to \$5,000, we were able to provide much-needed relief. Many of the families abruptly evicted from 29 San Juan Road have found alternative housing, ensuring they have a secure place to call home during the holidays.

We closed the GoFundMe account on Friday, December 15, so that we could get the last round of economic assistance into the hands of the evicted families as quickly as possible. Our dedication to the wellbeing of these families and the broader community of Pajaro does not end with this successful fundraising campaign.

We will continue our collaborative efforts by offering support in various forms, including housing navigation, public benefit enrollment, legal aid, mental health services, and other resources available through our family programs and community-based partners.

### **Preparing for Emergencies**

It can be a matter of life or death. Be proactive in protecting yourself and others; take the time to create a 5-minute plan to evacuate from fires. With a clear escape route, you can leave at a moment's notice, keeping your loved ones safe from harm.

Remember, waiting for official evacuation orders might be too late – act quickly when it feels unsafe.

To ensure a smooth evacuation process:

- Establish a meeting place for your family.
- Prepare an emergency kit containing essentials like medication, important documents, clothes, food, and water.
- Stay updated with weather reports and Red Flag Warnings.
- If it's time to leave, have your emergency bags packed and gather your family, including pets.



• Don't delay; evacuate promptly.
