a) FY 25/26 Budget

In addition to FRC and MOW constraints, Lift Line is experiencing escalating costs. We are re-evaluating plans to expand facility construction to focus on maintaining staffing and services. EED is also reducing staff. We're focusing on Enhanced Care Management as a way to offset some reductions. The May budget revise removed \$90K cost of living adjustment. Secondarily to that, programs that families and individuals in our community depend on. Medicare, Medi Cal, SNAP as well as all the other implications around some of those huge cuts. We are developing communication language targeting folks and working with the state and federal partners.

b) FY 25/26 Development and Communications Plan

There is a full Communications Plan in your packet. There is an ongoing need to be very much front end in the next couple of weeks on communications and paid advertising around federal funding. They told us they were going to propose these cuts.

c) Funding Update (Federal and State)

'Big Ugly Bill' passed House, now in Senate review with potential 30-50% federal funding cuts. Medicare/Medi-Cal reimbursement reductions could force immediate Enhanced Care Management layoffs. Nine California Republican House members voted for cuts despite advocacy efforts. July 4th deadline targeted by Republicans for bill passage.

6:55 10. Development Report-Tony Nunez (15 min)

We have raised \$1,002,016 raised through May, exceeding \$970,000 board-approved goal. Second consecutive year raising over \$1 million in general donations. FY 2025-26 fundraising goal set at \$1,094,974 with new donor relations position. Community Foundation hired away planned donor relations candidate, requiring restart of hiring process.

7:10 11. Finance Committee Update - Doug Underhill (15 min)

(a) FY 2025-2026 Budget Approval

We've increased reliance on prior year reserves due to AAA funding cuts, requiring \$221,000 for Meals on Wheels and \$56,000 for development. The new development position is intended to generate both donor and program revenue. Overall expenses show a 2.9% decrease from last year, primarily due to a reduction in one-time Monterey flood funding. Without that factor, core programs reflect 4.92% growth. Personnel costs are increasing 4.4%, and health benefits 14.8%, while other line items were tightened to offset costs. Specific program changes include: Admin nearly flat (+0.3%), Development up 14% (new hire), Meals on Wheels down 8.6% despite reserve use, Lift Line down 3%, Early Education down nearly 1%, Growth in WIC, CACFP, and ECM programs. Lift Line reducing one staff position due to escalating

costs and lower tax base expectations. Early Education (EDD) eliminating \$90,000 COLA adjustment, cutting one teacher and administrative support. Enhanced Care Management expansion contingent on staff meeting full caseload revenue targets.

The bill was finalized on July 3, and signed on July 4. CB has a list of implementation dates. CB is focused on impacts on agency. SnapEd was dismantled, we have a contract with the CA Association of Food Banks through October. The WIC voucher went from \$49 to \$43 coupon, only a 10% decrease which was less than expected. MediCal will have impacts however CB doesn't know to what extent. There will be a need for some advocacy at state and county levels around services. CB has been in contact with the Alliance as well to start the process of learning that information. Watsonville Hospital is also in danger. People are going to lose their healthcare and potentially lose their hospitals as well. CB is having candid conversations. CB is in an unpaid outreach community partnership. This will have a negative impact on

healthcare estimates.

Watsonville Hospital was in contact with Michael Schrader from the Alliance, and also Nicole Coburn from the county who say that 86.5K enrolled in Medicaid. The uninsured rate is only about 6% right now, that number will go up at the ER due to either uninsured and the underinsured. Those who have commercial insurance will see the price go up. Those in Monterey County, where hospitals are all independent healthcare (CHOMP, Natividad, Salinas Valley) will be hit hard. 3k are going to be kicked off of insurance. There is a medical provider tax, the QAF (Quality Assurance Fee), that comes in from federal government. The provider fee is going to be a big challenge, and they also have doubled the rural hospital fund. We're putting eggs into ECM/CalAIM basket as a way to mitigate against impacts to local contracts and funding sources.

Is there any way you can be more specific on each program? ADA is a MediCAL expense, there will be less participants that are eligible, there should be a functional correlation in the number of people able to go.

For the FRCs, or ECM the agency doesn't know if the reimbursement rates are going to stay the same.

The mid-term elections are just around the corner and the republicans don't want to lose across the board.

Some are immediate: SNAPEd and Work requirements for food for children. There are Medium and Long term risks as well that will need to be taken into account.

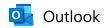

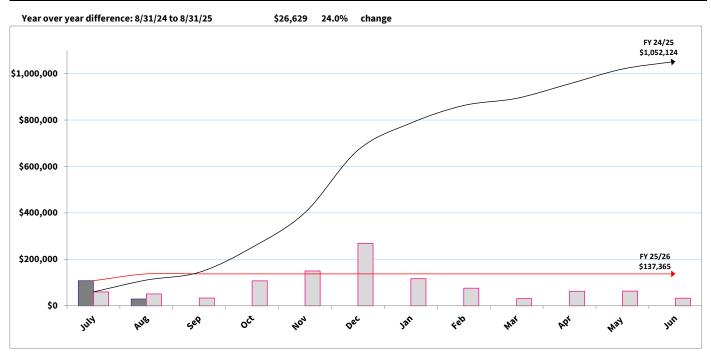
