## A Year of Impact—Built Together Across the Central Coast

As we look back at 2025 one thing is clear: this year's accomplishments are the result of a shared commitment—by staff, donors, foundations, volunteers, partners, and community members—working together to ensure families across the Central Coast could access support with dignity and respect.

Through collaboration and trust, the Family Resource Collective (FRC) strengthened the region's safety net, responded to crises, and invested in long-term stability for thousands of people.

What follows is a snapshot of what **we achieved together**—because lasting impact is never the work of one program or one organization alone.

## Providing Life-Saving Basic Services to Keep People from Falling Through the Safety Net

Across the Central Coast, our FRCs continued to serve as trusted access points for families navigating food insecurity, parenting stress, youth needs, and crisis situations.

### Youth Services

Together, we invested in prevention, connection, and healthy development:

- **1,583 hours of parenting classes**, strengthening family relationships
- **1,770 hours of youth activities**, creating safe, supportive spaces to learn and grow
- **5,339 summer lunch meals served**, ensuring children had access to nutritious food

### Family Services

When families faced urgent challenges, FRCs responded with compassion and action:

- **88,111 bags of food distributed**
- **13,433 individual crisis support visits**
- **863 mental health counseling visits**, supporting emotional well-being and resilience

## Expanding Access to Health Coverage

Navigating health systems can be overwhelming—especially during moments of instability.

Our FRCs served as trusted guides, helping families across the Central Coast secure and maintain health coverage while also leading [local outreach to vulnerable populations about upcoming changes to the federal and state policy](#).

From January through November, our FRCs accomplished the following:

### Medi-Cal Assistance

- **419 Medi-Cal enrollments**
- **58 Medi-Cal renewals**



- **262 Medi-Cal service visits overall**, including residents from Santa Cruz, Monterey, and neighboring counties

#### **Covered California Assistance**

- **83 Covered California enrollments**
- **72 renewals**
- **General service visits supporting families across the Central Coast**

By ensuring continuity of coverage, these services protected access to care when it mattered most.

## **Expanding Enhanced Care Management Across the Central Coast**

This year, Community Bridges significantly expanded **Enhanced Care Management (ECM)**—a statewide Medi-Cal benefit for individuals with complex medical and social needs.

In addition to serving Santa Cruz and Monterey counties, **ECM services expanded into San Benito County**, now supporting residents in **Hollister and surrounding communities**. Each ECM participant is paired with a dedicated care manager who coordinates physical health, mental health, housing, and social supports.

Care managers meet clients wherever they are—at home, in shelters, at medical appointments, or in the community—removing barriers to care and building trust. ECM is delivered in close coordination with Community Bridges programs, including **Elderday Adult Day Health Care, WIC, and the Family Resource Collective**, ensuring comprehensive, whole-person care that improves health outcomes and stability.

## Strengthening Housing Stability and Preventing Homelessness

Stable housing is foundational to health and family well-being. This year, our FRCs expanded both **housing prevention and stabilization efforts** across the Central Coast.

### Eviction Defense Collaborative

Through the Eviction Defense Collaborative, Community Bridges and partners provided free legal education, mediation, and advocacy to tenants facing eviction—helping keep people housed and minimizing harm.

Since 2021, the collaborative has assisted **approximately 500 individuals**, addressing unlawful detainers, negotiating repairs, and clarifying tenant rights.

In 2024–25 alone, **134 cases were closed**, resulting in rights protected, illegal practices stopped, housing benefits secured, and safer living conditions enforced. These outcomes demonstrate that eviction defense is not only compassionate—it is effective, equitable, and cost-saving for communities.

### Community Supports Housing Services

Our FRCs also expanded **Community Supports housing services for Medi-Cal members** who are unhoused or at risk of losing housing. Services included housing assessments, application support, housing searches, connections to local resources, and one-time financial assistance for security deposits.

By linking housing stability with health care, these services reinforced a simple truth: **stable housing leads to better health.**

**HAS YOUR LANDLORD THREATENED TO EVICT YOU?**

The Eviction Defense Collaborative, co-organizing from Community Bridges' Family Resource Collective (FRC), is a coalition of Santa Cruz County's most critical services to prevent legal evictions, ease the burden on vulnerable residents, and support landlords in what sometimes may be like an adversarial process.

## Standing With Immigrant Families During Critical Moments

Across the Central Coast, immigrant families continue to face uncertainty that can escalate quickly into crisis. This year, our FRCs deepened their role as trusted access points—providing timely information, legal connections, and life-stabilizing support to help families remain safe, housed, and together.

We partnered with community-based organizations, school districts, local governments, and legal advocates to deliver **immigration education, emergency preparedness, and direct assistance**. Thousands of residents received know-your-rights information, referrals to trusted immigration attorneys, and guidance on navigating rapidly shifting policies, ensuring families were not left to face complex systems alone.

A cornerstone of this work was participation in the [Childcare Safety Plan Coalition](#), a regional collaboration focused on helping families prepare for emergencies, including detention or deportation of a caregiver. Through this effort, our FRCs helped families complete **Childcare Safety Plans**, providing legal clarity and peace of mind by ensuring children would be cared for by a trusted adult in an emergency. Families also received support creating **family financial plans**, reducing long-term instability during crises.

For families facing immediate harm, our FRCs delivered rapid, life-stabilizing assistance through targeted emergency support via [Puentes Para Familias](#), including help with housing costs, utilities, child care, and bond-related expenses. These interventions prevented displacement, reduced trauma for children, and gave families time to access legal representation and long-term support.

Through this comprehensive approach—prevention, preparedness, and crisis response—our FRCs strengthened trust, safeguarded children, and upheld dignity for immigrant families across the Central Coast. This work reflects a core commitment: ensuring that no family faces fear or instability without support, and that every child has the safety and stability they deserve.

## Responding Swiftly to Emergencies—Together

The past year underscored the FRC's ability to respond quickly and equitably to large-scale emergencies across the Central Coast.

Following destructive ocean swells that damaged the Santa Cruz Wharf and harbor just before Christmas 2024, hundreds of workers were suddenly without income. In partnership with Community Foundation Santa Cruz County, **\$133,000 in emergency aid was distributed in just one week** through the Nueva Vista Community Resources team, supporting **266 workers** with rent, food, and essential expenses.

Then, near the end of 2025, La Manzana Community Resources completed the **[Pajaro Unmet Needs Disaster Assistance Program](#)**, working with the County of Monterey and Catholic Charities Diocese of Monterey.

Through **\$20 million in state recovery funds**, we helped distribute **\$5.4 million** to the more than **700 affected Pajaro households**—supporting evacuees, replacing essential belongings, addressing housing and vehicle losses, and strengthening long-term community resilience.

## With Gratitude—And Momentum

None of this work happens in isolation. Every family supported, crisis averted, and life stabilized reflects the collective effort of staff, volunteers, donors, foundations, partners, and community members who believe in showing up for one another.

Your time, trust, generosity, and collaboration made it possible to respond swiftly in moments of crisis and to build lasting pathways to stability across the Central Coast. Because of you, families were met with compassion instead of barriers, solutions instead of uncertainty, and dignity at every step.

Thank you for standing with us this year—and for continuing to help build a stronger, more connected community where everyone has the opportunity to thrive.
